

**CONTRACT RIDER
FOR
RACHEL FEINSTEIN**

THESE CONDITIONS ARE BINDING PARTS OF THE PURCHASER/RACHEL AGREEMENT.

This rider is attached to and made part of the BASS/SCHULER ENTERTAINMENT CONTRACT #_____ for the performance of **RACHEL FEINSTEIN** (hereinafter referred to as the RACHEL) and _____ (hereinafter referred to as the PURCHASER), on _____.

PURCHASER agrees to furnish the following items:

A) STAGE:

A secure stage approximately 8'x8'. PURCHASER shall arrange the seating so that the front row shall begin no more than four (4) feet from the front of the stage or no more than 12 feet away.

B) SOUND SYSTEM:

A quality sound system with corded microphone and stand.

C) ACCOMMODATIONS:

PURCHASER agrees to provide hotel accommodations at **THE HOLIDAY INN**, or the equivalent only when a Holiday Inn is not available. PURCHASER agrees to arrange for a nonsmoking room and a \$5 phone allowance.

D) TRANSPORTATION

When RACHEL arrives by plane, PURCHASER agrees to provide round-trip transportation between the airport and hotel. PURCHASER will insure that the Rachel is met at the gate by a knowledgeable representative. RACHEL will contact PURCHASER within 24-48 hours of the engagement date to establish arrival times and transportation particulars.

E) HOSPITALITY

PURCHASER will provide for meal allowance at the hotel restaurant where applicable or make comparable arrangements.

PURCHASER will provide RACHEL with school sweatshirt in LG or XL.

F) CANCELLATION

RACHEL shall have the right, upon 30 days notice, to cancel the engagement in the event RACHEL has been retained to appear in any motion picture, television motion picture, television series, and/or other special engagement. In the event that RACHEL cancels the performance, BASS/SCHULER will supply a suitable replacement agreed upon by both parties.

G) STATE WITHHOLDING

State Withholding: Some states levy a nonresident entertainer tax and require colleges to withhold a percentage from the final payment amount. If you plan on withholding any part of the agreed payment amount, this must be communicated to Bass-Schuler Entertainment DURING the negotiation process so that the deduction can be taken into account when calculating a performance price. If the withholding is not negotiated at the time of contracting, PURCHASER agrees that it will be solely responsible for any nonresident taxes incurred (i.e. the amount of the payment will be increased so that the final check will be for the amount agreed to).
